The Bachelor of Science in Economics is a four-year undergraduate program designed in full compliance with the Bologna Process framework. It consists of 240 credits according to the European Credit Transfer and Accumulation System (ECTS), distributed over eight semesters. The program follows the ECTS system, under which each ECTS credit corresponds to 25 hours of student workload, including lectures, laboratory sessions, self-study, and assessment activities.

Credits, Grading and GPA

Credits

The University of Wasit follows the Bologna educational system using the European Credit Transfer and Accumulation System (ECTS). The total number of credits for the degree program is 240 ECTS, with 30 ECTS credits per semester. Each ECTS credit is equivalent to 25 hours of student workload, including structured and unstructured learning activities.

Grading Scheme

Before the assessment process, results are divided into two subgroups: pass and fail. Thus, the results are independent of students who have failed the course. The grading system is as follows:

Calculation of CGPA

The cumulative grade point average (CGPA) is calculated by multiplying each course grade by its corresponding ECTS credits, summing the results, and dividing the total by the total ECTS credits of the study program (240 credits).

CGPA formula for the four-year Bachelor's degree:

$$CGPA = [(Grade\ of\ Course\ 1 \times ECTS) + (Grade\ of\ Course\ 2 \times ECTS) + \dots + (Grade\ of\ the\ Last\ Course \times ECTS)] / 240$$
